AWF HAS A STRINGENT GRANTMAKING SELECTION PROCESS TO MAKE SURE THAT ALLOCATED FUNDS ARE USED BY ORGANIZATIONS THAT ARE ACCOUNTABLE AND WELL-MANAGED. A SIGNED GRANT CONTRACT REQUIRES GRANTEES TO PROVIDE SIX-MONTH AND YEAR END REPORTS. ADDITIONALLY, A MEETING IS CONVENED TO PROVIDE AN OPPORTUNITY FOR FEEDBACK AND PROACTIVE PLANNING.

CREATED IN 2000, WOMEN ON BOARD IS A TRAINING PROGRAM THAT ADVANCES THE INCLUSION OF WOMEN AS LEADERS BY TRAINING THEM IN NONPROFIT BOARD GOVERNANCE AND THEN CONNECTING THEM WITH NONPROFIT BOARDS. SINCE ITS INCEPTION, THE PROGRAM HAS TRAINED OVER 2,700 WOMEN IN BOARD GOVERNANCE AND LEADERSHIP SKILLS AND CONNECTED HUNDREDS OF THESE WOMEN WITH NONPROFIT BOARDS. WOMEN ON BOARD WAS DESIGNED TO INCREASE THE PARTICIPATION AND DIVERSITY OF WOMEN SERVING ON NONPROFIT BOARDS IN METRO ATLANTA.
